At the regular Board Meeting, held in said Village and County in the State of Illinois at 6:30 p.m. on March 28, 2017 meeting was called to order by Mayor Schmit. The following official business was transacted:

Roll Call

IV. Presentation - Dan Miller

Mayor Schmit presented Fox Lake Street Department Supervisor, Dan Miller, with a plaque of recognition from the Village of Fox Lake on his retirement and for his dedication to the Village and its residents. Dan had over 15 years of service with the Village of Fox Lake.

V. Inclusion Pledge and Resolution

Mayor Schmit stated that The Lake County Inclusiveness Summit was held on February 21, 2017 alongside several Lake County municipalities. The Summit was sponsored by the Partnership for a Safer Lake County and opened by Lake County Board Chairman Aaron Lawlor. The Partnership is funded in part by the Lake County Community Foundation. One of the outcomes of the Summit was a request for participating agencies to pass a resolution in support of the "Welcoming and Inclusive Community Pledge." The resolution covers several areas of discrimination including Title VII protected classes as well as sexual orientation, immigration status and social identity.

Mayor Schmit then read the Pledge to the audience. Mayor Schmit asked if there were any questions. There were none.

Lake County's Welcoming and Inclusive Community Pledge

I pledge to stand against hate and discrimination and affirm that Lake County should be a welcoming community for all.

I am proud of Lake County's diversity. I recognize that at every level of American society, people of all backgrounds contribute to our democracy, culture, and economy. We must advance the fundamental rights and principles upon which the United States was founded, establishing the equality and dignity of all people regardless of their background.

I condemn any verbal or non-verbal attacks, harassment, or intimidation based on race, ethnicity, color, immigration or refugee status, religion or creed, gender or sexual orientation, age, mental or physical disability, veteran status, or other social identities, as well as discourse that disrespects or degrades people's identities, needs, and beliefs. From our schools to our neighborhoods and our government buildings, Lake County must be a place that respects our differences and believes that diverse perspectives create better outcomes.

VI. Administrator Update

Village Administrator Anne Marrin stated work is continuing with the Lakefront Park and thanked Tom Muelfelder and Dave Watkins for their overseeing of the project for the Village. Administrator Marrin stated that sewer televising and cleaning continues in the south system as we are currently in the Eagle Point area. The Water and Sewer Department has encountered some issues with roots in this section and have been removing them with specialized equipment. Construction resumed on the North Water Tower. The connections were made for the water main to the tower. Some of the

sections of the tower are currently being assembled on the ground and we are ahead of schedule. Administrator Marrin also stated that the IEPA sewer connection permit for Culver's has been reviewed by the Sewer and Water Department and the North West Regional and has been submitted for approval.

Administrator Marrin stated that the "Smother the Weeds" volunteer event at the Community Garden of Fox Lake was a great success. Thank you to Whistle Stop Café for donating wheelbarrows, beverages and hot coffee for the volunteers. Also, the Village of Fox Lake would like to thank Community Garden committee member Monica Marr for obtaining a \$1,500 grant from the Illinois Food bank to be used for 10 additional plots. These plots are available to low income families and veterans. One of the plots will be used by the master gardeners as a demonstration plot.

Administrator Marrin stated that applications for the Planning and Zoning Commissioners are now being accepted. The application is available on the Village website and an ad has been placed. Finally, Anne stated that Gewalt Hamilton met with IDOT on Thursday for the pre-construction meeting on the Village's Nippersink Blvd Project. Soil borings are being conducted and will continue into next week. This is one of the projects awarded Federal Funds (STP) of \$1,333,600.

VIII. Committee of the Whole

A. Finance

C. Parks and Recreation

- Saturday, April 22nd National Honor Society Garden Day at the Community Garden.
- Saturday, May 13th The High School Fishing Tournament, Launch and weigh –in will be at Ben Watts Marina and then lunch at the Lakefront Park.
- Wednesday, May 24th – Marriott Theater in Lincolnshire bus trip to see “See Loves Me.”
- Sunday, June 4th is the Fox Lake Triathlon, preparations continue.

Trustee Koske stated that Fox Lake’s Parks and Recreation Department is going after a new \$20,000 park grant called “Meet Me at the Park.” The National Recreation and Parks Association (NRPA) is collaborating with The Walt Disney Company – including Disney Citizenship, Disney| ABC Television Group and ESPN on “Meet Me at the Park.” This provides communities with resources to improve local parks through projects that connect kids with nature, promote healthy living and provide access to sports. Across the County, the general public can nominate a city for a chance to win \$20,000 for a local park. The city with the most nominations will be the winner! We will keep the community in the loop when it’s time to nominate.

Trustee Koske stated that work continues with the Lakefront Park on both the interior and exterior of the building.

D. Planning

There was nothing to report from Planning this evening.

E. Public Safety

Administrator Marrin stated that she will be asking for a motion to adopt the Illinois Vehicle Code in its entirety. The Village Board had previously adopted the Illinois Vehicle Code into a Village Ordnance. However, at the time of the adoption, the entire Vehicle Code was not adopted and only specific sections were adopted. This has created confusion in the prosecution of municipal Ordinances and also has prohibited the Village from prosecuting recently enacted Vehicle Code regulations. This new Ordinance will clear up the current conflict and allow for the prosecution of current and future modifications of the Code.

Administrator Marrin asked if there were any questions regarding amending the Village Code regarding drug paraphernalia. There were none.

Administrator Marrin asked if there were any question in the purchasing of Motorola portable radios for the Police Department. There were none.

Administrator Marrin asked if there were any questions regarding the Resolution 2017-R-14 regarding the “Partnership for a Safer Lake County.” There were none.

F. Sewer and Water

Trustee Murrey stated that he did not have anything to report from Sewer and Water this evening.

G. Streets

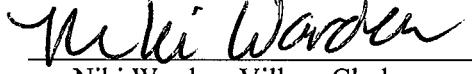
