**NOTICE OF ADMINISTRATIVE HEARING**

Please take notice that on ***Tuesday, June 19, 2018 at 9:30 AM*** a public hearing will be held before the Fox Lake Police Pension Board at 66 Thillen Drive, Fox Lake, Illinois, regarding the survivors pension application of the above applicant, pursuant to the applicable provisions of Article 3 of the Illinois Pension Code.

The public hearing will be held solely for purposes of considering/adjudicating Applicant's Motion to Quash, Motion to Seal, Motion to Compel, Demand for Bill of Particulars and the Village's Motion to Compel. At the culmination of this hearing the Board will also be issuing deadlines pertaining to lingering discovery, disclosure of witness lists, and dissemination of proposed exhibits. The Board will also be issuing a deadline for filing any additional pre-hearing motions and will be tentatively scheduling this matter for a hearing on the merits. The adjudication of the Applicant's underlying survivors pension application will not take place on this date. The Applicant and Village are entitled to be represented by legal counsel and present oral argument in support of/in response to the pending motions.

Pursuant to the applicable provisions of the Open Meetings Act, the Board may, in its discretion, adjourn into Executive Session during this hearing.
