Director Day and Commission Board Discussed

- Dunkin Donuts opening up the 3rd week of May 2018
- Beef Jerky Outlet is hoping to open by memorial Day weekend
- Ray Chrysler, Jeep, Dodge, Ram recently opened , waiting on grand opening date
 - Vehicles on corner of 134 & 12 will be moving
 - The Village Board required him to remove the vehicles from the corner of 134 & 12 within 90 days
 - Some vehicles will be moving to Industrial Ave and Ray will be coming before the Planning & Zoning Commission Board for a special use for that property
 - Searching for another location – Possibly the golf course vacant lot
 - Engineering approved for landscaping replacement
- Studio Hot Rods Road House
 - Working with the Village on bringing in a big festival at Lakefront Park and his business
 - Obtained a lease with Fox Waterway for boat slips and additional overflow parking
 - Approximately a \$1,000,000 investment for the community
 - Does not want to have gaming machines
- Classic Cinemas
 - \$2,000,000 expansion of movie theatre
 - Add theatres, new reclining seating
 - Possible entertainment liquor license
- Golf Course Property
 - 100 acres available
 - Potential developer and Village Board in discussion
- Sayles Property
- Old dealership building will be torn down
 - Potential developer for strip mall
- Downtown Art Installation 2018
 - “Share the View” ARTirondack Chairs
 - 14 Chairs total
 - Installed in downtown
 - Auctioned off with proceeds going to Promote Fox Lake & volunteer Fire Department
 - 40% to artist
- Murals for downtown
 - Vintage Fox Lake Postcards
 - Obtaining estimates from artists
- Lakefront Park
 - Recreation Strategic Planning Team is pulling together a master park plan
- Gazebo and Millennium Park
- Old Dominic's building, North West corner of 134 & 12
- North East corner of 134 & 12 property sold
 - In discussion with IDOT to lift the Route 12 access restrictions
- Liquor store, in old Vichy building, expanding with remodeled interior, received façade funding, new windows, doors and awnings
