

At the Board of Police and Fire Commission Meeting, held at the above address in Lake County Illinois on September 1st, 2020, the meeting was called to order at 5:07 pm by Board Commissioner Kenney. The following official business was transacted:

IV. Approval of previous Meeting Minutes:

Commissioner Trinski made a motion to approve the minutes for 8/11/2020, Kenney seconded the motion, all were in favor.

V. Unfinished Business:

- a. Background application statuses reviewed: The two candidates, who received the conditional offer from the Commission, successfully passed the psychological test, medical test, and POWER test. The current status of the eligibility list was discussed, and Chief Lee informed the Board that there will be no more hiring at this time.
- b. There are currently two candidates attending the academy, and they are scheduled to graduate October 2nd, 2020. According to the Macon County Academy Commander, they are doing well, and have passed the halfway point of their scheduled time at the Academy. Next SLEA Police Academy begins September 14th and runs through December 18th, 2020.
- c. Commissioner Kenney revisited the hiring concern with the recent legalization of recreational marijuana. Chief Lee requested that we reach out to the Commission's attorney after the Coronavirus Pandemic to finalize hiring conditions/concerns.

VI. New Business:

- a. Commissioner Trinski swore in Kyle Lemmer and Cameron Risner in anticipation of their entrance into the Academy on September 14th, 2020.
- b. Chief Lee updated the Commission on the status of our COPS grant in reference to the required SRO position for utilization of the grant monies. Pending possible modifications to the award due to the Coronavirus Pandemic and the school district.
- c. Chief Lee requested that the Board award Officer VanBuren permanent status as a Patrolman. Commissioner Trniski motioned, Commissioner Huffman seconded, all were in favor.
- d. Due to Commissioner Ravagni's recent resignation from the commission, the Board has welcomed newest Commissioner Steve Huffman. Commissioner Huffman is a retired Police Chief from Antioch PD, and resides in Fox Lake.
