**IV. Approval of previous Meeting Minutes:**

- a. Chief Lee updated the Commission on the status of the candidate that was recommended for hire, Michael Bulanda. The candidate successfully passed the POWER Test. Michael Bulanda will attend the September Academy class at College of DuPage.
- b. In regards to the minor edits to the Rules and Regulations, Commissioner Kenney informed the Commission that he has reached out to the Commission attorney, and is currently still working on this matter with the attorney.

**VI. New Business:**

- a. The Commission Board elections were held, with Commissioner Kenney nominating and motioning for Commissioner Trinski to be Chairman,

Commissioner Sadowski seconded and all were in favor. Commission Trinski nominated and motioned for Commissioner Kenney to be Secretary, to which Commissioner Sadowski seconded and all were in favor. Both Commissioners are appointed to their respective positions for the next term.

- b. Due to the Police Eligibility list being exhausted, the testing process is currently underway to find new recruits. Chief Lee updated the Board as to the status of the testing, noting that applicant numbers are down. With the deadline fast approaching mid-September, Chief Lee and the Board are hopeful that more candidates will test.
- c. Chief Lee requested that Michael Bulanda be sworn in to the rank of Officer during this Commission Meeting, prior to his attendance at the Academy the following week. Commissioner Sadowski swore in Michael Bulanda to his newly appointed position of Police Officer.
