V. Unfinished Business:

- a. Chief Lee updated the Board on the status of Officer Salgado, who is currently in the Academy. Chief Lee reports that she is doing well, is showing leadership skills and is set to graduate from the academy on April 28th, 2023.
- b. Chief Lee updated the Board on the remaining candidates on the primary eligibility register. Chief Lee discussed the background finding on the candidates and requested that they be rejected. The Commission voted and agreed to reject the candidates. The Board will notify the candidates in writing.
- c. Chief Lee reported to the Commission that Officer Bulanda is doing very well on FTO and will be released from FTO very shortly.
- d. Chief Lee announced that Officer Malczewski has announced his retirement, effective, June 1st, 2023. The Board wishes him well and thanks him for his many years of service.
- e. Chef Lee spoke briefly to the Board in regard to the number of classes the basic recruit academies now have due to the new 16 week academy curriculum. Due to

the extension by 2 weeks, every academy will now have one less class annually. This will have an effect on securing academy spots in the future.

VI. New Business:

- a. Due to the exhaustion of the primary eligibility list, Commissioner Trinski motioned extend the application deadline to allow candidates to apply until April 30th, 2023. Commissioner Kenney seconded all were in favor.
- b. Commissioner Kenney suggested that oral interviews could take place during a special meeting, sometime shortly thereafter.
