

- b. Chief Lee announced to the Board that our newest recruit, Officer Salgado, will start the academy in a few days, and with her hire and Officer Bulanda's recent graduation from the academy, we are now at full staff. Chief Lee mentioned as well that he is still attempting to get authorization from the Village for one more sworn officer.
- c. Chief Lee reported to the Commission that Officer Bulanda will now be on FTO and will give the Commission updates as to his progress.

**VI. New Business:**

- a. Chief Lee requested the Board to grant Officer Wolotowsky permanent status, as he will have completed his 18 month probationary period on January 27<sup>th</sup>, 2023. Commissioner Kenney motioned to grant Officer Wolotowsky permanent status, Commissioner Trinski seconded, all were in favor.
