At the Board of Police and Fire Commission Meeting, held at the above address in Lake County Illinois on May 2nd, 2023, the meeting was called to order at 5:03 pm by Board Commissioner Kenney. The following official business was transacted:

III. Approval of previous Meeting Minutes:

Commissioner Kenney made a motion to approve the minutes for 3/7/2023,

Commissioner Sadowski seconded the motion, all were in favor.

V. Unfinished Business:

- a. Chief Lee updated the Board on the status of Officer Salgado, who has recently graduated from the Academy. Chief Lee reports that she has done well in the Academy and has started FTO, effective May 1st, 2023.
- b. Commander Martin updated the Board on the remaining candidates on the primary eligibility register. Commander Martin discussed the background finding on the candidates and requested that they be rejected. The Commission voted and agreed to reject the candidates. The Board will notify the candidates in writing.
- c. Chief Lee requested that Officer Salgado be ceremoniously sworn in at the next Village Board Meeting, May 9th. Commissioner Sadowski and Kenney will be present to attend and swear her in.
- d. Chief Lee reports that Officer Bulanda is off of FTO and is doing well.
- e. Chef Lee informed the Commission that the next academy class will start on August 28th, 2023 and would like to have some candidates from the new list to attend.

- f. Chief Lee shared with the Commission that during budget considerations this year the Police Department was able to get approval for a 30th Officer to be hired in this fiscal year.

VI. New Business:

- a. Commissioner Kenney discussed the weighted scoring in relation to what other departments and testing companies are suggesting. The Board elected to keep the weighted score for candidate testing as is and will re-evaluate at a later date if necessary.
- b. Commissioner Kenney detailed that there are 20 viable candidates from this last round of testing, which ended on April 28th, 2023. The Board voted to have oral interviews on Saturday, May 13th, 2023. Ms. Trammell will contact and schedule the candidates accordingly.
- c. Commissioner Kenney will notify both the candidates that failed the testing process via email. He will also notify the candidates who passed the testing process, and have them submit for preference points.
- d. Chief Lee mentioned the possibility of recruiting for lateral hires again after this round of candidates has been exhausted or expired.
