At the Board of Police and Fire Commission Meeting, held at the above address in Lake County Illinois on November 7th, 2023, the meeting was called to order at 5:04 pm by Board Commissioner Kenney. The following official business was transacted:

III. Approval of previous Meeting Minutes:

Commissioner Kenney made a motion to approve the minutes for 10/17/2023, Commissioner Moore seconded the motion, all were in favor.

IV. Public Comments:

V. Unfinished Business:

- a. Officer Lechner and Chief DeServi informed the board of the results of the background investigations conducted on the candidates of the Primary Eligibility list. A few candidates withdrew due various circumstances surrounding the results of their background investigations.
- b. Chief DeServi and Officer Lechner spoke with the Commission regarding an individual who they were requesting be removed from consideration due to background investigation findings. Commissioner Kenney motioned to remove the candidate from consideration, Commissioner Trinski seconded, all in favor.
- c. Chief DeServi and Officer Lechner presented the board with favorable background results on one applicant. After reviewing the results, Commissioner

Kenney made a motion to send the candidates a conditional offer of employment, Commissioner Trinski seconded, and all were in favor.

VI. New Business:

- a. Commissioner Kenney stated that he would notify the candidates in writing that they were no longer being considered for the patrol officer position, and extend a conditional offer of employment to those that were approved by the Board.
- b. Chief DeServi mentioned an issue with issuance of preference points based on education as described in the statute. Commissioner Kenney stated that he would reach out to the Board Attorney for clarification.
- c. Chief DeServi also requested to re-open testing as soon as possible, with a tentative deadline for the end of December due to the Holidays. The Commission agreed and were in favor.
