At the Board of Police and Fire Commission Meeting, held at the above address in Lake County Illinois on April 2nd, 2024, the meeting was called to order at 5:15 pm by Board Commissioner Kenney. The following official business was transacted:

III. Approval of previous Meeting Minutes:

Commissioner Trinski made a motion to approve the minutes for 3/5/2024, Commissioner Moore seconded the motion, all were in favor.

V. Unfinished Business:

- a. Chief DeServi updated the Board as to the status of the two recruits currently attending the academy. Both recruits are doing well and are set to graduate on the 26th of April.
- b. Officer Lechner had completed several background investigations on candidates from our most recent round of testing including a lateral candidate and Chief DeServi reviewed them with the Commissioners. A few candidates had questionable actions and events in their employment and financial past, others deceived on their applications, simply did not respond, or were hired elsewhere. Upon review of the candidates, Commissioner Kenney motioned to send failure notices to those that failed the background, Commissioner Moore seconded it, all were in favor.
- c. Chief DeServi notified the Board that the candidate that the board had provided a conditional offer to, that requested additional time to decide, has responded by declining the conditional offer.

VI. New Business:

- a. The three candidates that were given conditional offers after the last Commission meeting were sworn in at Chief DeServi's request. They are set to attend the Academy on April 29th, 2024.
- b. Chief DeServi spoke to the Board about a certified candidate that looked positive with the appropriate training and FTO. The reason for separation from his previous department was due to lack of training. Chief DeServi requested a conditional offer for this candidate. Commissioner Trinski motioned to send the candidate a conditional offer, Commissioner Moore, seconded it, all were in favor. Commissioner Kenney is to send out the conditional offer.
- c. Chief DeServi informed the Board that there was one candidate with prior military experience, college and life experience that she felt would be an asset to the Department. She requested a conditional offer be extended to him. Commissioner Kenny motioned to send the candidate a conditional offer, Commissioner Trinski seconded, all were in favor.
- d. Chief DeServi informed the Board that the Officer recently released from FTO is doing well.
