V. Unfinished Business:

- a. Chief DeServi updated the Board as to the status of the three recruits currently attending the academy. Two of the recruits had sustained injuries while participating in defensive tactics training. It is anticipated that they will be healed and back to full participation in a few days to a week, pending Doctor's orders. Other than minor injuries setting them back, they are doing well.
- b. Chief DeServi requested that the Board review the rules in reference to the physical ability portion. In the meantime, the recruit was hired as a CSO and will attempt to pass the test again prior to the next academy.
- c. Chief DeServi notified the Board that a previous lateral applicant reached out to her stating that she was ill and was in and out of the hospital, which is why she could not communicate with the Department. The lateral applicant still expressed interest in joining the Department, however, the Department no longer has any Officer positions available. Chief DeServi informed the candidate that if anything should change, she would be contacted.

- d. Chief DeServi explained to the Board that the lateral Officer that is currently on FTO is doing well.

VI. New Business:

- a. The three candidates that were given conditional offers after the last Commission meeting were sworn in at Chief DeServi's request. They are set to attend the Academy on April 29th, 2024.
- b. Chief DeServi and the Board of Commissioners requested that Attorney John Kelly review and amend the current Rules and Regulations to require candidates to provide proof of passage of the POWER Test during the background investigation stage. Attorney John Kelly agreed and informed the Board that he would have a draft for them to review at the next meeting.
- c. Attorney John Kelly also stated that he would update the section in the Rules regarding citizenship to coincide with the recent State Law that was passed.
