The goal is to establish a Behavioral Threat Assessment Management (BTAM) Team that would employ a strategic, multidisciplinary framework to prevent violence and address situations of concern. This helps ensure community safety by identifying and mitigating potential threats before they escalate. There is no budgetary impact.

B. Resolution 2025-R-17 Resolution Approving the Mayor of the Village of Fox Lake to Sign and Thereby Enter into an Intergovernmental Agreement Between the Village of Fox Lake and the Village of Lake Villa for the Usage of the Fox Lake Temporary Holding Cells

This item is to approve the mayor to Sign and Thereby Enter into an Intergovernmental Agreement Between the Village of Fox Lake and the Village of Lake Villa for the Usage of the Fox Lake Temporary Holding Cells. This is an update to a 2023 agreement that clarifies liability coverage. There is no budgetary impact.
