**BOARD MEETING**  
**Monday, January 20, 2025 - 9:30 a.m.**

**1. Meeting Called to Order**

President Eric Geske called the meeting to order at 9:32 a.m.

**2. Pledge of Allegiance**

The Pledge of Allegiance was recited.

**3. Roll Call**

Board Members present were Eric Geske, Bill Monsen, Louis Leny, Rick Howell and Ed Becker. Also present: Attorney Laura Goodloe, Village Finance Director Mary Locher, Jonathan Bertsche and Michael May of Lauterbach & Amen. Recording Secretary Carol McMullen attended via zoom.

**4. Approval of Agenda**

A motion was made by Louis Leny to approve the Agenda as presented; second by Ed Becker. All Ayes; motion carried.

**5. Public Comments - None at this time.**

**6. Approval of Minutes**

A motion was made by Louis Leny to approve the minutes of the Quarterly meeting of 10-21-2024 as presented; second by Bill Monsen. All Ayes; motion carried.

**7. Accountants/Treasurer Reports/Financial Reports**

Jonathan Bertsche reviewed the 11-30-2024 Monthly Financial Report showing total net position held in trust for pension benefits at \$24,653,970.91. Total disbursements for 09-01-2024 through 11-30-2024 were \$19,379.95.

A motion was made by Eric Geske to approve the 11-30-2024 L&A Financial Report as presented; second by Rick Howell. All Ayes; motion carried.

A motion was made by Eric Geske to accept the bills as presented on the L&A Financial Report for the period 09-01-2024 through 11-30-2024 in the amount of \$19,379.95, and to pay the bills as they become due; second by Rick Howell. Roll call vote taken: Eric Geske - Aye. Bill Monsen - Aye. Louis Leny - Aye. Rick Howell - Aye. Ed Becker - Aye. Motion carried.

Approval of 2025 Cost of Living Increases - A motion was made by Eric Geske to approve the 2025 Cost of Living Increases as calculated by Lauterbach & Amen; second by Louis Leny. Roll call vote taken: Eric Geske - Aye. Bill Monsen - Aye. Louis Leny - Aye. Rick Howell - Aye. Ed Becker - Aye. Motion carried.

Active Member Statements - The Active Member Pension Contribution Statements were prepared by Lauterbach & Amen. A copy was handed to each member and a copy will be placed in each members pension file.

State Street/Verus Investment Reports - The 11-30-2024 IPOPIF Statement showed year-to-date ending balance of \$23,755,689.65. This amount is an increase (net of fees) by 10.83% since inception.

Status of Investment Accounts/Money Market Accounts/Local Bank Accounts and/or BMO Harris Account/Cash Flow Needs/Cash Management - Cash flow needs were discussed.

A motion was made by Ed Becker to increase the monthly deductions from IPOPIF to BMO Bank for the period August through December 2025 in the amount of \$155,000 per month; second by Rick Howell. Roll call vote taken: Eric Geske - Aye. Bill Monsen - Aye. Louis Leny - Aye. Rick Howell - Aye. Ed Becker - Aye. Motion carried.

Ratification/approval of FY2024 Annual Audit - The audit was finalized as of 12-13-2024 and issued.

A motion was made Eric Geske to ratify and approve the FY2024 Annual Audit; second by Louis Leny. All Ayes; motion carried.

#### **8. Attorney Report**

Status of Gliniewicz Survivors Pension - Attorney Goodloe discussed the status of this matter. This matter has been finalized; no further action is needed.

Brandy Lechner Disability Update -The Board convened for a second hearing on this matter. The parties will be filing post hearing briefs and will be setting this for a third hearing. This matter remains pending.
