At the Board of Police and Fire Commission Meeting, held at the above address in Lake County Illinois on February 11th, 2025, the meeting was called to order at 5:12 pm by Board Commissioner Kenney. The following official business was transacted:

III. Approval of previous Meeting Minutes:

Commissioner Trinski made a motion to approve the minutes for 1/7/2024, Commissioner Moore seconded the motion, all were in favor.

IV. Public Comments:

V. Unfinished Business:

- a. Investigator Lechner updated the Commission on the remaining candidates from the current list. Some candidates withdrew due to being hired elsewhere, others withdrew due to not having the POWER card prior to the background process. Other candidates were removed from consideration due to inconsistencies in their application, financial issues, unethical and criminal behavior. Commissioner Kenney is to send notification via mail to the candidates removed from consideration.
- b. Chief DeServi explained to the Commission that the candidate currently in the Academy is doing well and progressing as he should.

VI. New Business:

- a. Chief DeServi reported to the Board that she would like to re-open testing due to the exhaustion of the current list. There is not enough time to complete the hiring process prior to the next academy date in April. Chief DeServi explained that we have been able to confirm 2 seats in the September academy and would like to open testing sometime in April. The Board discussed that testing could open at

that time and close at the end of May to hold oral interviews the first week of June. This should provide enough time to complete the hiring process prior to the September academy.

- b. Due to the timing of testing and oral interviews, the Board determined that there is no need for a Commission Meeting on June 3rd, 2025. The June Commission Meeting will be held on the same day as the oral interviews.
- c. Chief DeServi asked the Commission what level of participation they would like to have during the promotional testing. The Board decided that a more observational, rather than interacting role would be best so that they can get a better understanding of the promotional testing process.
