At the Board of Police and Fire Commission Meeting, held at the above address in Lake County Illinois on May 6th, 2025, the meeting was called to order at 5:15 pm by Board Commissioner Kenney. The following official business was transacted:

III. Approval of previous Meeting Minutes:

Commissioner Trinski made a motion to approve the minutes for 2/11/2025, Commissioner Moore seconded the motion, all were in favor.

V. Unfinished Business:

- a. Chief DeServi updated the Commission on the remaining candidate from the current list. The candidate withdrew due to being hired elsewhere, and a potential lateral failed to disclose information in reference to his previous employment. Commissioner Kenney is to send notification via mail to the lateral candidate removed from consideration.
- b. Chief DeServi explained to the Commission that the candidate currently in the Academy has resigned and returned to the military.

VI. New Business:

- a. Chief DeServi reported to the Board that we will need 3 hires and would like to open testing now. As previously discussed by The Board and the Chief testing will open now until the end of May and Oral Interviews will be held the first weekend of June. This will allow enough time to conduct background investigations for entry into the September Academy.
- b. Chief DeServi requested that Officers Dahlgren and Aviles be given permanent status as they have completed their 18-month probationary period. A motion was made by Commissiner Kenney, Commissioner seconded, all were in favor.

- c. Chief DeServi informed the Commission of the progress in reference to promotional testing. She explained that she is re-writing some of the questions provided to her from the promotional testing vendor, due to lack of relevance to the Department. So far, she has received interest from 7 of the 11 eligible candidates to test and is waiting for a response from the last potential candidates. The promotional testing is currently scheduled for the end of July.

VII. Next Meeting Date:

Next scheduled Commission meeting is June 7th, 2025 at 9:00 a.m. Oral interviews are to be conducted at this time.
