At the Board of Police and Fire Commission Meeting, held at the above address in Lake County Illinois on July 10th, 2025, the meeting was called to order at 5:10 pm by Board Commissioner Kenney. The following official business was transacted:

III. Approval of previous Meeting Minutes:

Commissioner Kenny made a motion to approve the minutes for 6/9/2025, Commissioner Trinski seconded the motion, all were in favor.

V. Unfinished Business:

- a. Chief DeServi and Officer Lechner reviewed the candidate backgrounds with the board. Of the 24 candidates on the list, all but 3 either failed or withdrew. There were a few candidates that were hired elsewhere, candidates that were disqualified due to not having the POWER card at the time of background, and some who just withdrew from consideration. A handful of candidates never responded or returned the background packet and a few presented criminal, behavioral, drug and alcohol issues during the background investigation. The Chief requested that they are not considered for the position and be notified as such. All Commissioners agreed and Commissioner Kenney will send out the notifications.
- b. Chief DeServi and Officer Lechner requested that 2 candidates be extended a conditional offer of employment. The Commission agreed and Commissioner Kenney will send the conditional offers to the candidates
- c. The Commission confirmed that a candidate will be disqualified from consideration if they fail to meet the deadline for the submission of documents relevant to the background investigation.

VI. New Business:

- a. Chief DeServi requested permanent status for Officer Renteria for completing his probationary period. Commissioner Trinski granted permanent status and documentation of status.
- b. Chief DeServi updated the Board regarding the upcoming promotional test for Sergeant. Candidates are expected to take the written test on July 14th, and the assessment on July 28th. The assessment will take candidates through case scenarios and decision making. Chief DeServi provided the Commission with the preference points, merit points and longevity points for scoring.
