2. Public Comment of Proposed Project: Veterans' Park Improvement

Jordan Feldman, Grant Community Baseball coach, and parents Jenny Meyer and Dani Hopple commented on accessibility concerns, limited spectator space, and parking challenges at the park. Suggestions for the new playground included pour-in-place surfacing instead of sand, improving ADA compliance, reducing or relocating basketball courts to another park to allow this site to better serve baseball and softball and addressing the walkways to reach all of the fields. They are excited for the improvements proposed, including the concession stand improvements. All encouraged staff to consider park users in future planning.

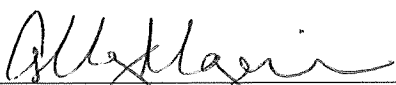
