At the Board of Police and Fire Commission Meeting, held at the above address in Lake County Illinois on August 12th, 2025, the meeting was called to order at 5:05 pm by Board Commissioner Kenney. The following official business was transacted:

III. Approval of previous Meeting Minutes:

Commissioner Moore made a motion to approve the minutes for 7/10/2025, Commissioner Trinski seconded the motion, all were in favor.

IV. Public Comments:

V. Unfinished Business:

- a. Chief DeServi update the Board on the status of 2 most recently hired recruits. They have passed the medical and their start date will be within the next week. After a short week with the Department, they will be starting the Academy in September.
- b. Chief DeServi explained that the next academy starts on January 4th, and that we have secured 2 spots in that class.
- c. Mrs. Trammell updated the status of applicants currently testing. Chief DeServi requested that The Board hold the oral interviews on Saturday September 20th, instead of the 27th, in order to be sure to meet the Academy deadlines and to avoid scheduling conflicts around the holidays. The Board agreed and determined that the closing date for the test should be moved up a few days, in order to meet the deadlines.

VI. New Business:

- a. Mrs. Trammell explained to the Board that in order to change the Commission meeting date, public notice must be given, in advance, before the change can be

implemented. The Village is aware and will be publishing that notice within the next few days.

- b. Chief DeServi updated the Board regarding the promotional test for Sergeant. She stated that the assessments went well, but unfortunately there were 3 that failed overall.
- c. Commissioner Kenney suggested the weighted scores for promotional testing be adjusted and will be reaching out to the Commission Attorney for further guidance.
- d. Chief DeServi mentioned a new law that will be enacted January 1, that requires the release of candidate background files. The Board will further discuss and determine how this will be handled.
- e. Commissioner Kenney stated that he has completed the initial list for the promotional exam and will disseminate the results soon.
- f. Commissioners Moore and Kenney both expressed interest in attending the Commission Seminars in November. They are both looking into it further and are planning to register.

Next scheduled Commission meeting is October 14th, 2025 at 5:00 p.m.
