A: Discussion regarding off premises signage and possible amendments to the Village of Fox Lake Sign Ordinance

Trustee Brian Marr making the presentation

- A proliferation of sandwich, small real estate signs and banners, some getting large and destroying the visual quality of the Village
- Village Board members suggested the Sign Ordinance be revisited
- Downtown businesses want to have patrons coming to their business
- Permission granted to one business must be granted to all businesses
- Members asked to drive the Village and make notes as to what works and what does not work
- See what works in other towns
- Could be as simple as a sign seen in Grayslake pointing to “Business District”
- You will not make everybody happy with any restrictions that may be imposed
- Talk to business owners for any of their suggestions

B: Mr. Gauger

- The number of sandwich boards a business can have at one time in one location was not specified
- Members should come prepared to the next meeting, with the sign ordinance, ready to discuss this mater

C: Director Day:

- No limit to how many temporary signs are allowed under a permit
- Firm up and clarify what we have
- Wayfinding signage to attract people to our downtown
- Placement of directional signs into Downtown
- Signage to be budgeted for 2017

- Square footage maximum for signs
- Existing signs
- Need for off-site signage for unique businesses in residential areas
- Restrictions for political signs
- Business directory at train station/part of package to be budgeted for 2017
