XIII. Attorney Comments

Village Attorney, Howard Teegen stated that back in 2013 the Village Board approved an economic incentive agreement with Val's Fresh Market. There is a provision in the agreement that indicates that if he was to spend \$75,000 in improvements on the property and produce receipts for those expenditures by December 31, 2015, the agreement would then be extended through November 2019. Howard stated at this time he has not provided the receipts for the expenditures and we are not quite sure if he has spent those funds or not. The indication is that he has not spent the funds as he has not produced the receipts. The Village has not been paying him the incentives since December 31, 2015 however we need to get some closure on the matter. Howard suggested to the Board that the Village sends him a letter giving him 10-14 days to produce the receipts and if he

cannot comply the incentive is no longer in affect. Another option could also be that he has not presented the receipts so the incentive agreement is over. Howard asked for guidance from the Board on how they would like to proceed.

There was discussion amongst the board regarding the agreement and the Board gave Howard direction to send a letter of request for expenditure documentation per the agreement and for them submit back within 10 days.
