- **Gyorgos Café located at 7233 State Park Road has opened under new ownership.**
- **Bloody Mary Fest will be held on Sunday July 14<sup>th</sup>, 2019**
- **Farmers Market is currently happening every Tuesday from 4pm-8pm**
- **Murals**
  - **Two (2) murals have been completed in the downtown.**
    - Village mural completed on the side of the Dollar General building
    - Promote Fox Lake mural completed on the side of Asis Hair shop
    - Mural started on the Lakes Realty building owned by Pat Smarto
    - The Village is currently looking for another location for the third (3<sup>rd</sup>) mural

*Commissioner Schultz made a motion to adjourn the Planning & Zoning Commission Meeting, Seconded by Commissioner Warden.*


