Ryan asked to meet with someone on the Board who doesn't have an active role in the construction contract. He said costs will escalate to unreasonable levels. He said the project used four large drills. Three worked perfectly. Given normal, reasonable construction conditions, they should have all worked perfectly. The fourth drill did not work, even when Kennedy brought in two outside drilling companies. Ryan hopes someone from the Board can have a conversation with Kennedy to make progress and work something out.

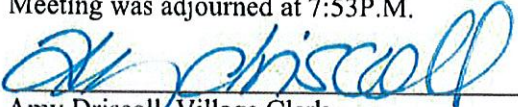
**20. Adjournment (Made in Executive Session)**
